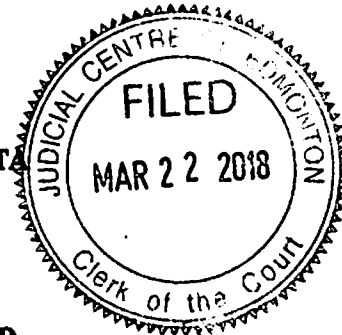

**UPON** this Appeal coming on for hearing and to be spoken to;

**AND UPON** being referred to the Affidavit of Carla Avery, which Counsel for the Appellants has undertaken to file;

**AND UPON** hearing from Counsel for the Appellants and Counsel for the Respondent;

**AND UPON** being advised that certain of the Defendants subject to the Order of the Provincial Court of Alberta consolidating various claims by the Respondent in this Action (the "Consolidated Actions") for the purpose of the summary dismissal application heard and determined by the Honourable Madam Judge L. D. Young, which judgment is the subject of this Appeal, have subsequently settled with the Respondent, including James Reid and Diane Reid (collectively referred to as the "Settling Appellants");

**AND UPON** being advised that the Appellants in 76 of the Consolidated Actions in the list appended to the Affidavit of Carla Avery have not settled with the Respondent (collectively referred to as the "Non-settling Appellants");


**AND UPON** being advised that Counsel for the Appellants intends to withdraw as Counsel of record for the Non-settling Appellants;

**AND UPON** hearing from individual Non-settling Appellants present in person, including Dennis Loughlin, Helen Engels, Carlos Schenkel and Ricky Schenkel;

**IT IS HEREBY ORDERED THAT:**

1. This Appeal is appropriately filed in respect to the Consolidated Actions and may be continued as a consolidated Appeal in respect of the 76 Non-settling Appellants, as set out in Schedule "A" appended to and forming part of this Order.

2. This Appeal is dismissed as against the Settling Appellants in respect of each of the 674 Consolidated Actions, as set out in Schedule "B" appended to and forming part of this Order;
3. This Appeal shall be adjourned to be spoken to on May 10, 2018 at 9 o'clock in the morning in respect to the scheduling of the Appeal for hearing, and any procedural matters that may need to be determined in order to schedule the Appeal for hearing.
4. In the event any Non-settling Appellant has not confirmed its intention to pursue the Appeal in accordance with Paragraph 5 below, prior to May 3, 2018, this Appeal shall be dismissed in respect to that Non-settling Appellant.
5. A copy of this Order shall be served by Strathcona Law Group LLP on each of the Non-Settling Appellants, together with a Form of Notice referencing the return date and time set in paragraph 3 hereof, and requesting that each Non-settling Appellant(s) who intends to pursue the Appeal confirm to counsel for the Respondent that they intend to do so, and provide an electronic or post office address at which they can be served in the event they intend to self-represent, or where they have retained counsel, provide the name and contact information for the counsel retained by them.
6. Each of the Non-settling Appellants who intend to pursue the Appeal shall provide the Form of Notice referred to in paragraph 5 above, duly completed, together with their contact information for service of future documents either electronically, by facsimile or by courier, to counsel for the Respondent, Norton Rose Fulbright Canada LLP, 400 - 3rd Avenue SW, Suite 3700, Calgary, AB T2P 4H2, Attention: Jud Virtue, to be delivered and received on or before May 3, 2018.
7. Strathcona Law Group LLP shall also provide to each of the Non-settling Appellants an Authorization to Release Confidential Information, to be returned to Strathcona Law Group LLP on or before May 3, 2018 by any Non-settling Appellant who consents to the release of their contact information to other Non-settling Appellants, which Authorization will serve as a consent by the named Non-settling Appellant(s), once executed, to the release by Strathcona Law Group LLP of their contact information to any other Non-settling Appellant(s) who also consents to the release of their contact information.




